1:03 P.M. Judge and court reporter appear by video from Forest County Courthouse, along with Attorney Attorney Frederick B Melms for Kirk Bangstad and Minocqua Brewing Company, LLC. Attorney Matthew Martin Fernholz appeared by video for Lakeland Printing Co., Inc., Walker Communications, LLC, and Gregg Walker. Heather Holmes and Gregg Walker appear by video. Attorney Timothy M Johnson appeared by video for Kirk Bangstad and Minocqua Brewing Company, LLC. Attorney Jeffrey Leavell appeared by video for Society Insurance Company, a Mutual Company and West Bend Mutual Insurance Company. Court statement-here today on Atty. Melms' motion to quash order to appear before court commissioner; brief reviewed. Melms speaks to motion/order to appear - timing/premature; unlawful/abuse of court commissioner discretion; burdensome. Fernholz responds/objects to motion, speaks to hearing as discovery tool; judgment in place; production of documents; injunction of disposal of assets; orders are appropriate and objects to request to quash. Melms' statement/responds to objection.

Court statement - references Ch. 816; court does not quash the order. Court - supplemental proceeding is discovery tool; production of documents is allowed/references Crown Castle case. Court will allow defendant to bring documents at time of hearing/not required 5 days in advance; quashes request for injunction of disposal of property at this time, references Ch. 813 and Ch. 242 and other remedies available; not part of commissioner's order. Court orders production of documents going back to judgment date only, 10/27/23, not 5 years. Court speaks to document 601 - not entitled to Bangstad personal tax returns other than for income/wages; monies identified from time of judgment, 10/27/23; inventory/equipment/motor vehicles, if there is one, from time of judgment, 10/27/23; financial statements for years 2023 and 2024 for Brewery and Bangstad; nos. 7 and 8 quashed/court notes these would be public records; nos. 10, 11, 12, 13 quashed; no. 14 quashed as to last 3 years. Court quashes portions of order dealing with injunction. Court - defendants loan applications from 10/27/23 to present, if any. Melms/Court statement. Fernholz to prepare order regarding hearing before Court Commissioner.

Fernholz requests Bangstad bring copies of all documents to hearing as one set will be marked for the record; granted by the Court. No. 6 personal financial statements are for both defendant Bangstad & Brewery for years 2023 and 2024, if exists. No. 13, 10/27/23 to present.

Atty. Melms Motion for Ex Parte Temporary Injunction and Motion to Stay Enforcement discussed. Court finds Ex Part motion not appropriate at this time. The hearing on Motion to Stay has been removed from the calendar for 3/28/24. Court will have JA contact parties to schedule. Melms statement. Court sets briefing schedule for counsel to respond to Motion to Stay. Attys. Fernholz/Leavell - 30 days to file response. Atty. Melms - 10 days to reply. Melms to prepare order regarding briefing schedule on Motion to Stay.

Court prohibits any execution/seizure/collection of property at this time. Court notes this can be reviewed again after the Motion to Stay. adj. 2:07 p.m.
